Green tech: Luther advises OCELL on Series A financing round

Frankfurt a. M./Munich, 4 February 2025 – 10 million euros for climate-resilient forests: OCELL, with legal support from Luther, is receiving Series A financing to expand its Al technology and expand in Europe.

The green tech start-up OCELL is receiving €10 million in a Series A financing round to drive its expansion in Europe and further develop its cutting-edge, Al-based platform for more efficient forest management and for developing high-quality CO₂ certificates. Currently, over 800,000 hectares of sustainable forest land in a total of eleven countries are managed using OCELL software.
