Berlin – The shareholders of Spreewaldkonserve Golßen GmbH (Spreewaldhof) have entered into an agreement with Andros Deutschland GmbH to sell the traditional company with the "Spreewaldhof" brand. The takeover is subject to clearance by the German antitrust authority.
